Rapid Response offers high-quality services to communities, businesses and individuals who are addressing economic impacts, industry changes and natural disasters that may lead to worker layoffs.

Rapid Response services are flexible and strategically designed to bridge economic and workforce development. The program brokers partnerships and tailors solutions for businesses and workers during any stage of the business cycle.

The Alaska Department of Labor & Workforce Development has a team of Rapid Response specialists located throughout the state who provide information, resources and services to businesses and workers in transition.

Rapid Response is a proactive program designed for two major purposes:

- To help growing businesses obtain the information and resources needed to stay competitive, including links to skilled workers.
- To respond to layoffs and closures by quickly coordinating services and providing immediate aid to management and the affected workers.

The Rapid Response team will work with employers and any employee representatives to quickly maximize public and private resources to minimize the disruptions on businesses, affected workers and communities associated with job loss.

Rapid Response can provide customized services on site at an affected business, accommodate any work schedule and assist through the entire transition process.



Other Rapid Response services include but are not limited to:

- Information on the Worker Adjustment and Retraining Notification Act (WARN).
- Coordination of strategies with economic development and other programs that avert or minimize potential workforce reductions.
