Subject: Worker Adjustment and Retraining Notification Act

Dear Ms. Erben:

The Worker Adjustment and Retraining Notification Act (WARN) requires certain employers to give advance notification of a planned layoff or shutdown which results in a loss of work for more than six months, termination or a certain reduction of work hours.

This letter serves as notification that the current contract which Centerra has with the USMS 9th Circuit Court is due to expire on September 30, 2023

The following constitutes available information concerning this action:

- All personnel working on the USMS 9th Circuit Court in Alaska are affected and will have their employment end on September 30, 2023. This separation from employment is expected to be permanent and employees will not have bumping rights to another position. Employees will be paid through the last date of employment in accordance with state law. See below for list of locations and union points of contact per location.
- The number of affected employees: 27
